Uniform Policy

Introduction

At Sneinton St. Stephen's, we believe that wearing a school uniform fosters a sense of belonging, pride, and unity in line with our school values of Love, Joy, Unity, and Hope. This policy has been written with a strong focus on supporting families financially. There is no expectation that parents/carers purchase school-branded clothing, ensuring that uniform requirements remain accessible and affordable for all.

Our school community is diverse, and we are committed to ensuring that every child feels a sense of inclusion and belonging through our uniform policy. While the uniform helps children feel part of the school, we also celebrate and respect the rich cultural backgrounds represented within our school. We are mindful of the importance of cultural identity, and our uniform policy seeks to support every child in feeling valued and respected within our inclusive environment.

Legal Framework and Statutory Requirements

This policy complies with the following statutory requirements:

Education Act 1996: Ensures that schools can specify uniform requirements and provide support where needed.

Equality Act 2010: Ensures that uniform policies are inclusive and respect cultural, religious, and individual needs.

School Admissions Code 2021: Requires that uniform policies do not disadvantage any student.

Our policy also follows the Department for Education's guidance on school uniforms to ensure affordability and accessibility for all families.

Aims

- To promote a sense of identity and belonging within our school, while celebrating our diverse community.
- To ensure equality and reduce financial pressures on families.
- To comply with our obligations under the Equality Act 2010 and ensure respect for cultural backgrounds.

Uniform Requirements

We expect all children from Foundation 2 onwards to wear school uniform.

Main Uniform:

- Red sweatshirt or red cardigan
- White shirt or white polo shirt
- Black or grey trousers, dress, skirt, or school shorts
- Red and white checked summer dresses
- Black closed-toe shoes or black trainers (see note on footwear below)
- Headaddress: Black or red scarves only

We do not stipulate which of this clothing should be worn in each season, and parents/carers are encouraged to decide what is appropriate for their children's comfort throughout the year. Staff may offer support through communications or suggestions directly to parents/carers when necessary.

Footwear

For health and safety reasons, **open footwear** such as Crocs, flip flops, or sandals is not permitted. All children should wear **closed-toe** shoes or trainers.

Optional School Branded Items:

Uniform items can be purchased from a variety of retailers to ensure affordability. School-branded items are available from the school office but are entirely optional.

We are able to provide Sneinton St. Stephen's branded coats, cardigans, and sweatshirts. However, there is no requirement for children to wear branded items. Unbranded red cardigans or sweatshirts from any retailer are acceptable.

Pre-loved Uniform

We recognise the importance of keeping uniforms affordable for all families. Pre-loved uniform giveaways are offered regularly throughout the year. Families in need of additional support can also request pre-loved uniform items from the school office.

PE Kit:

Parents and carers will receive an **induction booklet** at the start of the school year outlining PE days. Any changes to PE days throughout the year will be communicated via the school's communication apps.

On PE days, children should wear:

- White T-shirt
- Black or red shorts
- Dark grey or black jogging bottoms/leggings
- Black trainers

Children will wear their PE kit throughout the entire day. Changing into uniform will only be required for **after-school enrichment clubs** or sporting events that occur at the end of the school day or for a small part of the day.

We encourage children to continue wearing their school sweatshirt or cardigan over their PE kit throughout the day.

Labelling

We strongly encourage all parents/carers to ensure that **all clothing and personal items** are clearly labelled with their child's name to avoid loss or mix-ups. This helps to ensure that lost items can be returned quickly.

Other School Equipment and Items

Reading Folder

As part of our commitment to promoting reading and fostering a love of **Reading for Pleasure**, each year, we provide a **branded reading folder** to all Foundation 2 pupils as a welcome gift. These folders are available for other year groups to purchase but are not required.

Hot and Extreme Weather Guidelines

During extreme weather conditions, adjustments will be made to support children's comfort. Parents/carers will be informed of any uniform adjustments through our communication apps.

In hot weather, hats and sunglasses are permitted. We recommend hats that offer better sun protection, such as bucket hats or neck-covering hats. Parents/carers should note that hats and sunglasses are brought to school with the understanding that the school cannot be held responsible for lost or broken items.

Jewellery

We permit the following types of jewellery:

- Small ear studs
- A wristwatch (not a smartwatch)
- Religious necklaces and jewellery

While the ideal is that all jewellery, including religious items, should be removed for PE and swimming, we understand that this may not always be possible for certain religious or cultural reasons. In such cases, we ask parents/carers to provide a **rash vest** for swimming to ensure the jewellery is safely covered.

Badges, Lanyards, and Accessories

The school provides pupil leadership area badges to recognise leadership roles within school.

However, children should not wear non-school-related badges, lanyards, or other accessories on their uniform.

We also discourage accessories on bags, such as key rings, due to the risk of theft or damage.

Bags and Personal Items

Children may bring a bag for their packed lunches and reading books. Each child has a peg in the class cloakroom to store their items. However, please note that items brought into school and kept on the premises are at the owner's risk.

Water Bottles

The school provides every child with their own **water bottle**, which can be used both in the classroom and during PE. There is no need for children to bring their own water bottles from home.

Pencil Cases and Equipment

The school provides all necessary stationery and equipment for every child. No children will need or should bring a pencil case or any other stationery to school.

For **KS2** pupils, the school provides:

- A pencil case with all necessary equipment
- Headphones and a stylus for use with their iPads

In **KS1 and EYFS**, the school provides communal stationery for all pupils to use.

Mobile Phones and Electronic Devices

Children should not bring mobile phones into school. In exceptional cases where a mobile phone is needed (e.g., for children who walk home alone), the phone must be handed into the school office at the start of the school day and collected at the end of the day. The school does not accept responsibility for any damage or loss of phones.

Our approach to mobile phones aligns with the school's **behaviour policy**, and any breach of this policy will be dealt with accordingly. Pupils who do not follow these rules may have their phones confiscated, and they will be stored safely in the office until a parent/carer collects them.

No electronic devices should be brought into school unless they are required for a medical need and an agreement has been made with the SENDCo. This ensures the safety and well-being of all pupils.

Confiscation of Non-uniform Items

The school reserves the right to confiscate any non-uniform items brought into school. Confiscated items will be labelled and placed in the school office for collection by the child at the end of the day or their parents/carers.

Responding to Incorrect Uniform

At Sneinton St. Stephen's, we understand that there may be occasions where parents/carers are unable to adhere to the uniform policy for short periods of time. In these cases, we will work with parents/carers to support them, and no child will be disadvantaged.

- Children wearing incorrect uniform may receive a gentle reminder.
- In some cases, the school may **provide spare uniform or PE kits for** children to change into. When this happens, the child will be given clean, appropriate uniform to wear for the day.

Our aim is to maintain our standards while recognising the challenges families may face from time to time.

Reasonable Adjustments

In some circumstances, particularly for children with Special Educational Needs and Disabilities (SEND), the school may make reasonable adjustments to the uniform requirements. These adjustments will be handled on a case-by-case basis, in consultation with the school's SENDCo and in communication with the child and their parents/carers.

Equality and Accessibility

Sneinton St. Stephen's is committed to ensuring that our uniform policy is inclusive and does not disadvantage any pupil based on financial circumstances, religion, gender, or cultural needs. We recognise and respect the diverse cultural backgrounds of our school community and seek to ensure that all children feel a sense of belonging to the school. Any parent or carer who requires support with uniform or has cultural considerations should contact the school office or their child's teacher for assistance.

Monitoring and Review

This policy will be reviewed annually to ensure it continues to meet the needs of the school community and adheres to the latest DfE guidelines. Feedback from parents, pupils, and staff will inform future updates to ensure the policy remains fair, inclusive, and accessible.
